

## **Amapi Pro End User License Agreement (EULA)**

### **Software License Agreement and Limited Warranty**

PLEASE READ THIS LICENSE AGREEMENT CAREFULLY BEFORE OPENING ANY COMPUTER READABLE MEDIA PACKAGE(S). BY OPENING ANY COMPUTER READABLE MEDIA PACKAGE(S), YOU AGREE TO BECOME BOUND BY THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT. #### **1. Return Policy**

You may return this product to where you purchased it for a full refund within 30 days from the date of purchase, unless any computer readable media package is opened.

You own the compact disk(s) on which the Software is recorded or fixed, but the Software is owned by e frontier Inc. and e frontier America, Inc. or its suppliers and is protected by the copyright laws of Japan and international copyright treaty provisions. The copyright restrictions of this license agreement extend to any further updates, software patches, or bug fixes made available to you by e frontier Inc. and e frontier America, Inc., whether distributed on floppy disk, compact disk, or in an electronic format via download, BBS, ftp, e-mail, etc.
