

## Installing Interactive Physiology

*You must keep the CD in the CD-ROM drive at all times.*

### To install on Macintosh®

- 1 Start the external CD-ROM drive, if needed, then start your Macintosh.
- 2 Place the CD in the caddy or CD-ROM drive. The CD icon *Interactive Physiology* appears on the desktop.
- 3 Double-click the icon. The *Interactive Physiology* window appears.
- 4 Double-click the icon *Installer Files*. The icon *Double-Click to Install* appears.
- 5 Double-click the icon. The Install dialog box appears.
- 6 Click Install.
- 7 When a message reports that installation was successful, click Restart.
- 8 To start the session, double-click the *Interactive Physiology* folder on the CD.

### To Install on Windows 3.1™

- 1 Start the external CD-ROM drive, if needed, then start your computer.
- 2 Place the CD in the caddy or CD-ROM drive.
- 3 Start Windows.
- 4 From Windows Program Manager, choose Run from the File menu.
- 5 In the Run dialog box, click the Browse button.
- 6 In the Browse dialog box, select the drive and file for the *Interactive Physiology* CD. For example, if your CD is on drive letter d, click d: in the Drives list box. In the File Name list box, double-click **setup.exe**.
- 7 In the Run dialog box, click OK. The *Interactive Physiology* Setup window appears.
- 8 Follow the instructions on the screen, then click OK.
- 9 To start the session, double-click the *Interactive Physiology* group.

### To Install on Windows 95®

- 1 Start the external CD-ROM drive, if needed, then start your computer.
- 2 Place the CD in the caddy or CD-ROM drive.
- 3 Start Windows.
- 4 Click the Start button, and then click Run.
- 5 In the Run dialog box, click the Browse button.
- 6 In the Browse dialog box, select the drive and file for the *Interactive Physiology* CD. For example, if your CD is on drive letter d, click d: in the Look In list box. In the Browse box, double-click **setup.exe**.
- 7 In the Run dialog box, click OK. The *Interactive Physiology* Setup window appears.
- 8 Follow the instructions on the screen, then click OK.
- 9 To start the session, click the Start button, point to Programs, point to *Interactive Physiology*, and then click *Interactive Physiology*.
