## Installation Instructions

### For Windows® 3.1

1. Start your PC.
2. Insert the compact disc into the CD-ROM drive, label-side up.
3. In Program Manager, choose the Run command from the File Menu.
4. In the Command Line box, type the letter of your CD drive, a colon, a backslash and the word "setup." (Example: d:\setup) Press ENTER.
5. For further hints and tips, read the installed README file.

### For Windows® 95

1. Start your PC.
2. Insert the compact disc into the CD-ROM drive, label-side up.
3. When the *JFK Assassination* CD is used for the first time, a Start-up Window will be displayed giving the options to INSTALL or EXIT. Double click INSTALL.
4. If the Start-up Window is not displayed: first, double-click the icon representing your local computer; second, double-click the icon representing your CD-ROM drive; then, double-click the SETUP icon.
5. The next time the *JFK Assassination* CD is used, the options START, REINSTALL, and EXIT will be displayed. Double-click the START icon.
6. For further hints and tips, read the installed README file.

### For Mac® OS 7.0 and higher

1. Start your Macintosh®.
2. Insert the compact disc into the CD-ROM drive, label-side up.
3. Drag the *JFK Assassination* folder to your hard drive.
4. To launch *JFK Assassination*, double-click the icon representing the version which matches the capabilities of your Macintosh®.
5. You may move the *JFK Assassination* folder and rename the icons to suit your preferences. We recommend renaming the preferred icon "JFK".
6. For further hints and tips, read the installed README file.

(Note: *JFK Assassination* may also be launched directly from the CD by double-clicking the appropriate icon.)
