INSTALLATION INSTRUCTIONS

INSTALLING FOR WINDOWS® 95:

1. Insert the Power Rangers CD in your computer's CD-ROM drive.
2. Select "Install Power Rangers" from the window that appears.
3. Follow the on-screen instructions.

INSTALLING FOR WINDOWS® 3.1:

1. Insert the Power Rangers CD in your computer's CD-ROM drive
2. In Program Manager, select "File/Run" from the menu.
3. Type "d:\setup" where "D" is the drive letter of your CD-ROM drive.

4. If Power Rangers says you need to "Upgrade Windows", take the following steps. Otherwise, proceed to step 5.
 - Select "Upgrade Windows" from the window that appears.
 - Follow the upgrade instructions.
 - After your computer restarts, re-run the Power Rangers set-up program as you did in steps 2 and 3.
5. Select "Install Power Rangers" from the window that appears.
6. Follow the on-screen instructions.

INSTALLING ON A MAC:

Copy the install folder from the Power Rangers CD-ROM to your hard drive by dragging it to the hard drive icon on your desktop.

UNINSTALLING POWER RANGERS APPLICATION:

Power Rangers Zeo is designed to be easily removed from your computer when you are finished playing. To uninstall Power Rangers, select the Power Rangers icon as you normally would to play, and choose "Uninstall" from the title screen. Then, follow the on-screen instructions. Windows 3.1 users may want to remove Win32s and WinG from their computer, although doing so is not recommended, as it may cause other programs that use these components to stop working.

OVERVIEW OF GAME

The goal for each level is to ward off adversaries and retrieve all fragments of each of the five Zeo crystals. Each crystal is fragmented and scattered throughout a level. It is necessary to obtain 100% of the crystal fragments. After doing this, the Rangers are teleported to a Level-Boss location. Upon successfully defeating the boss, the player advances to the next mission.

HINTS

RETRIEVE ZEO CRYSTALS TO GET ZEO WEAPONS -

Rangers will automatically draw energy from picking up crystal fragments. Whenever a Ranger has at least 50% of a crystal for a given level, that Ranger will be able to utilize their special weapon. Note that Rangers can't jump as high or run as fast with weapon in hand, but weapons can be put away at any time.

RUNNING -

All Rangers can run by pressing the left or right direction key plus the up key OR by double tapping (and holding) the left or right direction key. On a game pad, the diagonal up/left and up/right will allow the Rangers to run, as well as the double tap.

COMBO MOVES -

Spin kick and punch (up arrow with kick or punch key)- the female rangers will perform a forward flip kick instead of the normal spin kick in this case. Jump Kick by pressing forward while jumping, then hit 'kick' when ready.

SPECIAL ZEO ATTACKS -

After getting the ZEO weapon, hold the up key PLUS the kick/punch keys for:

Red Ranger: Spin-around sword swipe

Green Ranger: Spin-around axe swipe

Blue Ranger: Spin-around blade swipe PLUS: Normal 'punch' key evokes special forward flip with the blades for extra damage!

Yellow Ranger: Spin-around nun-chaku swipe

Pink Ranger: all kick/punch combos launch projectile from shield

Black Ranger: all kick/punch combos launch projectile

FINISHING A MISSION -

After retrieving 100% of the crystal fragments on a given level, the player will automatically transport to the level boss location. Upon defeating the boss, the player has successfully completed that level and will be taken back to mission control to receive the next mission.

REGENERATE HEALTH -

Rangers regain health when they are not in use. For example, if a Ranger is too low on health to be used (in the "red" zone), he/she will not be available for current play. While playing the game with another Ranger however, all wounded Rangers will be in a resting state, making it possible to select the previously unavailable Ranger after a few minutes of rest.

PROJECTILE WEAPONS -

Pink and Black Rangers have projectile weapons which can be used after the designated 50% of crystals have been retrieved. Projectiles do little damage, but are advantageous against certain level bosses and cogs.

COGS -

You will encounter 4 different types of Cogs during your missions:

Purple	easiest, most common
Green	smarter and stronger than purple
Yellow	harder still, special roll attack
Red	hardest, shoots lasers

DIRECTIONAL INDICATORS -

There are arrows indicating a general direction for the player to progress scattered throughout the game, particularly in areas that have alternate paths.

SAVE GAME -

You can save games anytime during gameplay. Do so at the beginning of each new level AND when fighting a BOSS. Note: a folder of saved games can be found on all platforms in the support and util folders.
